

DONATION AGREEMENT

on Voluntary Monetary Donation to Support the Work and Activities of the Videomedeja
Video Art Association

Article 1 - Subject of the Agreement

This Donation Agreement (hereinafter: the “Agreement”) sets out the terms of a voluntary monetary donation made by an individual or legal entity (hereinafter: the “Donor”) to the Videomedeja Video Art Association (hereinafter: the “Association”).

A donation constitutes a voluntary monetary contribution without any obligation on the part of the Association to provide the Donor with goods, services or any other consideration.

The donation is intended to support the work, programmes, projects and activities of the Association and the achievement of its statutory objectives.

Article 2 - Acceptance of the Agreement

This Agreement is published on the Association’s official website and is available to the Donor before the donation is made.

By making a donation, the Donor confirms that they have had the opportunity to review the contents of this Agreement and accept its provisions.

The Agreement shall be deemed accepted for the specific donation on the date the payment is recorded in the Association’s bank account, or the donation is recorded through an official electronic donation system.

Article 3 - Amount and Method of Donation

The Donor independently determines the amount of the donation.

The donation may be made through the official donation channels published by the Association on its official website.

Article 4 - Source of Funds

The Donor confirms that they have the right to dispose of the funds being donated and that their source is not contrary to applicable laws and regulations.

The Donor is solely responsible for any tax or other obligations that may arise from making the donation.

Article 5 - Donor Information

The Association will not publicly disclose the Donor’s information in connection with the donation without the Donor’s prior consent.

Donor information is processed and stored in accordance with applicable personal data protection laws and regulations.

Article 6 - Independence of the Association

Acceptance of a donation does not grant the Donor the right to influence the Association's programme, artistic, editorial or organisational independence.

The donation does not create a partnership, agency, employment or other relationship between the Donor and the Association, except for the relationship arising from the donation itself.

Article 7 - Amendments to the Agreement

The Association may amend or supplement this Agreement.

The version of the Agreement that was published and available to the Donor at the time the donation was made shall apply to that specific donation.

The current version of the Agreement is available on the Association's official website.

Article 8 - Final Provisions

Relations not regulated by this Agreement shall be governed by the applicable laws and regulations of the Republic of Serbia.

This Agreement is drawn up in the Serbian language and published electronically on the Association's official website. The Association may publish an English translation of the Agreement for the information of Donors. In the event of any discrepancy between the Serbian-language version and the translation, the Serbian-language version shall prevail.

Effective from: 1 September 2026.
